

# Community Council Meeting

## March 16, 2021

Jenny Leavitt presented the 2021-2022 Plan (see next page)

Trust Lands will no longer allow a full time teacher to be funded from this funding. So, Jenny changed it to funding a Reading Intervention Teacher and a .36 Classroom Teacher. If they still will not allow the .36 Classroom Teacher, she will have to move the Reading Paras to this funding and move the Classroom Teacher to another funding.

Council Members will receive an email from Cheryl for their digital signature to approve the Plan. They will need to sign it when they receive the email.

Other items: New books for the take home library were discussed. Jenny said she has purchased \$1,000 worth of books for the lower levels and with the grant she just received from the District she will be purchasing more for the higher level books.

Micklee Hiatt:

Micklee asked about the Young Dr's program and Lego League and Coding Club. Jenny explained that Young Dr's started in February – it is virtual. Lego League and Coding Club was through a grant that we lost funding for. We were not selected for the grant again. We are looking for another grant. Council Members asked about PTO helping fund these programs or use Title 1 funds. Jenny said if we could get parent volunteers it would also keep costs down.

We would probably have to choose one after school program to do, not both. There may be an alternate program the students would enjoy. We are checking into this.

Jenny will talk to the faculty and see who is interested in teaching an after school program.

Ivins Heritage Days – Micklee would like to have Red Mountain represented here. School Choirs were cancelled for this year by the district in Elementary schools. We hope to have it back in the Fall.

Council Members approved the Trust Lands Plan for 2021/2022.

# Trust Lands Plan 2021/2022

## Goal #1:

80% of students will demonstrate growth from the beginning of the year on DIBELS reading assessment.

## Academic Areas:

Reading

## Measurements:

We will measure student growth based on students' composite scores on the Acadience DIBELS assessment. 80% of students will be expected to make typical or better growth by the end of year.

## Action Plans:

1. We will retain a highly qualified reading teacher to target students needing specific help with reading.
2. We will partially fund an additional teacher in order to reduce class sizes. This will allow teachers to meet with students in smaller groups for reading instruction.

## Expenditures:

Salaries and Employee Benefits - Reading Intervention Teacher - \$18,963  
- .36 Classroom Teacher - \$26,812
