Title I Parent Information

RMES is a Title I school. That means our school receives additional funding and support for academic programs that other schools do not have. Title I is a federal program through ESSA, the Every Student Succeeds Act.

- RMES is 6th of 11 Title I schools in WCSD
- Due to great support filling out the Free/Reduced form we **increased by about \$30,000** in funding than last year!

Currently we have 6 para-professionals who do small group reading interventions that are paid from Title I funds. We also fund 1 Extended-day kindergarten teacher.

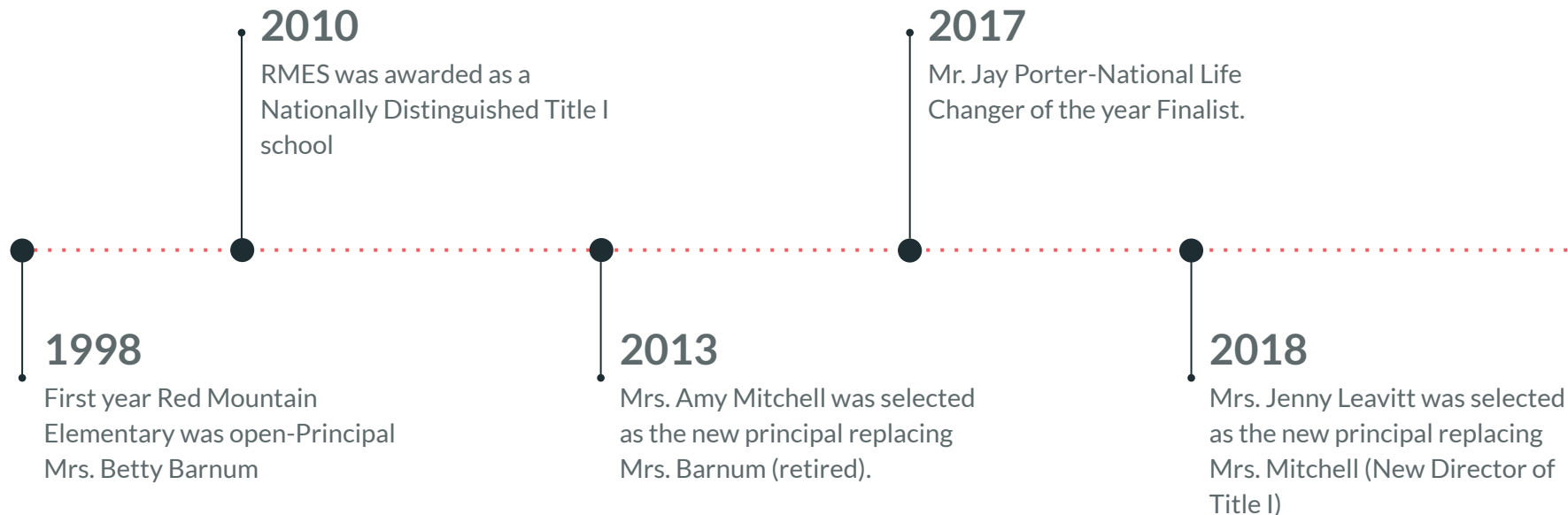
Student Education Plan (SEP) Conferences

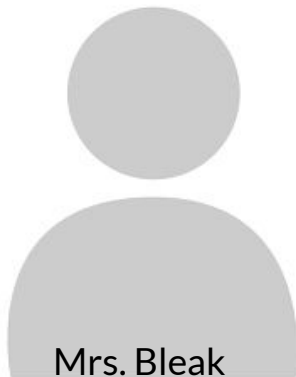
